Post-Conviction Investigation

The Federal Public Defender (FPD) of Washington, D.C. through panel Attorney Matthew Peed retained my services to investigate a Habeas §2255 petition filed by Anderson Straker. In 2009, Straker and five (5) codefendants were convicted in District Court, Washington, D.C. of a 2005 international Kidnapping and Murder Conspriacy of a United States (US) citizen that occurred in Trinidad, West Indies. Straker and the five (5) co-defendants were sentenced to Life imprisonment without parole. When all filings were complete, the USAO conceded to a new trial for six (6) defendants.

United States vs. Anderson Straker, et al - 06-CR-106 JB - Kidnapping and Murder Conspriacy

"On 2006, Anderson Straker and eleven (11) co-defendants were indicted in the District Court of Washington, D.C. for a planned kidnapping for ransom of a US Citizen who eventually died in the custody of the kidnappers. After the death of the US Citizen, his body was dismembered and packaged into two (2) containers and buried into two(2) unmarked grave sites. All the events occurred in Trinidad, West Indies. An investigation into the matter was conducted by the United States Attorney Office (USAO) and the Federal Bureau of Investigation (FBI), as well as the Trinidad And Tobago Police Service (TTPS). This was a death penalty eligible case.

Defendant Straker's Habeas §2255 petition claimed attorney ineffective assistance, joint venture investigation violations between the USAO and TTPS, and 4th and 5th amendment violations. An investigation that was conducted in Trinidad revealed that the petition claims had some merit. The investigation in Trinidad also revealed aspects of prosecutorial grand jury and witness misconduct; FBI misconduct on assaulting defendant Straker, advisement of rights, and a FBI Agent having intimate relations with decedant's niece; Ineffective assistance against the trial attorney and the trial investigator for failing to investigate incidents in Trinidad and failing to have witnesses located, interviewed and available for testimony at motions and trial matters. Colusion between co-defendants and the TTPS; And finally, colusion between the USAO and a co-defendant that gave testimony against the six (6) defendants that went to trial.

The USAO conceded to a new trial for six (6) defendants.

Criminal Defense Investigation

The Office of the Public Defender Anne Arundel County (OPDAAC) retained my services to investigate the criminal charges filed against Raynard Boston, reconstruct the crime scene that involed the client allegely discharging of a firearm, consult on Anne Arundel County Police Department's (AACPD) general orders and standard operating procedures, consult on AACPD's Police Tactics, consult on AACPD processing crime scene procedures, and reviewing, investigating and critiquing AACPD detective's investigation.

State of Maryland vs Raynard Boston - 02-K-13-00243 - Attempted 1st Degree Murder & 1st Degree Assault

"On 2-15-2013, Raynard Boston was a patron at a night club where a dispute arose between Mr. Boston and the night club security officer. Mr. Boston was assaulted by the security officer and the security officer was alledgedly shot with a handgun by Mr.Boston. A second subject was injuried by the gun fire. All these events were captured by the night club CCTV cameras and observed by numerous witnesses. The AACPD arrived on the scene, attended to the injuried victims, preserved the crime scene, investigated the crime, and processed the crime scene. Mr. Boston was devloped as a suspect and subsequently arrested and charged with Attempted 1st Degree Murder and 1st Degree Assault."

An AACPD Crime Scene Search Unit responded to the crime scene, processed and photographed the shooting crime scene, and collected evidence, but failed to diagram the shooting crime scene and take any measurements of the physical evidence recovered.

Our crime scene reconstruction consisted of the crime scene being diagramed, measurments taken of the collected evidence and the evidence placement, as well as reviewing the CCTV video suveillance with the statements of the witnesses and the collected evidence. The reconstruction of the crime scene revealed that the AACPD officers and their supervisor failed to properly preserve the crime scene. The AACPD Crime Scene Unit processed the crime scene after it had been contaminated by not only witnesses, but police officers as well. The State of Maryland and the AACPD based their whole case against Mr. Boston on the CCTV video surveillance recordings and identification of Mr. Boston on eye witness testimony. The reconstruction of the crime scene and revealing the AAPCD failure to properly secure and process a crime scene in violation of AACPD general orders and standard operating procedures, and a flawed investigation by AACPD detectives led to a successful defense of Mr. Boston.

Criminal Defense Investigation

The Law Office of M. Dennis Murphy retained my services to investigate the criminal charges filed against John Delich, reconstruct the crime scene that involved police officers' discharging their firearms, consult on Anne Arundel County Police Department's (AACPD) general orders and standard operating procedures, consult on AACPD's Police Tactics, consult on AACPD's "Use of Force" investigation involving police officers discharging their service issued firearms, and reviewing, investigating, and critiquing AACPD detective's investigation.

State of Maryland vs John C. Delich - 02- K-15-CR-0000 - 1st Degree Assault on police officers.

"On March 15th, 2015, John Delich was accussed of pointing and firing a loaded semiautomatic firearm at three (3) Anne Arundel County Police Department (AACPD) officers, who had responded to Mr. Delich's home for a "man with a gun" call for service. As four (4) officers surrounded Mr. Delich's house to investigate the "man with a gun" call for service, Mr. Delich opened and exited his garage door to investigate the unknown intruders (officers) on his property armed with a loaded semi-automatic handgun. Three (3) officers confronted Mr. Delich at the garage door entrance and an exchange of gunfire was reported by the police officers. Mr. Delich suffered a gunshot injury as he closed his garage door for cover and a barracde situation was initiated by the police. None of the police officer's suffered any injuries. Mr. Delich was eventually arrested and charged with three (3) counts of 1st Degree Assault on a police officer."

The AACPD conducted a "Use of Force" investigation into the discharging of the three (3) officers' service issued firearms and the gunshot wounding of a suspect. An AACPD Crime Scene Search Unit processed and photographed the shooting scene and collected evidence. The three (3) officers' actions in the "Use of Force" investigation was ruled "Justified" by the AACPD.

The crime scene reconstruction consisted of the crime scene being diagramed, measurments taken of the bullet enry and exit holes to include trajectory angles by using the photographs taken at the scene by AACPD and actual physical inspection of the gunshots destruction evidence. Inspection of Mr. Delich's garage, garage door (open and closing), trajectory investigaion of Mr. Delich's garage, interior and exterior of his house from bullets striking the property and walls to include his vehicle inside the garage, as well as the trajectory evidence of the bullet that struck Mr. Delich.

The reconstruction of the crime scene revealed Mr. Delich was armed with a loaded semi-automatic handgun when he opened and exited his garage; that Mr. Delich had not fired his handgun at any police officer at the scene, as reported by the officers; that Mr. Delich was fired upon first by one of the officers and Mr. Delich fled back into his garage; Mr. Delich ran to the back of the garage and closed the garage door; as the garage door closed, two (2) other police officers fired their service issued firearms at Mr. Delich; the two (2) officers reported that Mr. Delich had pointed his handgun at the officers in a threatening manner before they (officers) fired upon Mr. Delich; physical evidence revealed that Mr. Delich suffered a single gunshot injury to his lower leg from the gunfire of a police officer while in the back of the garage (blood evidence)after he had started closing the garage door; trajectory evidence revealed that the two (2) officers could not have fired at Mr. Delich before the garage door was closing; the trajectory angles of the officers' firing their service firearms was more consistent with the garage door closing as the officers were firing their service firearms; the physical evidence at the crime scene did not corrobbarate the officers verision of events and that the two (2) officers testimony was not factual.

A judge found Mr. John C. Delich not guilty of all 1st Degree Assault charges on the police officers.

Criminal Defense Investigation

The Office of the Public Defender Anne Arundel County (OPDAAC) retained my services to investigate the criminal charges filed against Calvin Johnson, reconstruct the crime scene that involed the police officer's discharging of his firearm, consult on Anne Arundel County Police Department's (AACPD) general orders and standard operating procedures, consult on AACPD's Police Tactics, consult on "Use of Force" investigation involving a police officer discharging his service issue firearm, and reviewing, investigating and critiquing AACPD detective's investigation.

State of Maryland vs Calvin Johnson - 02-K-06-002570 - 1st Degree Assault on a police officer

"On 11-3-2006, Calvin Johnson, while operating his motor vehicle, was was accused of attempting to run over a uniformed Anne Arundel County police officer. The police officer had attempted to execute a traffic stop on Mr. Johnson. The police officer exited his patrol vehicle and reported that Mr. Johnson aimed his vehicle at the police officer and drove directly towards the officer, pinning the officer against his patrol vehicle. This action by Mr. Johnson caused the officer to open fire on Mr. Johnson from a stationary position next to his patrol vehicle. Mr. Johnson suffered on gunshot injury and his vehicle was struck numerous times from the gunfire. The officer was not injuried in the offense. Mr. Johnson was subsequently arrested and charged with 1st Degree Assault on a police officer."

The AACPD conducted a "Use of Force" investigation into the discharging of the officer's service issued firearm and the gunshot wounding of a suspect. An AACPD Crime Scene Search Unit processed and photographed the shooting scene, and collected evidence, but failed to diagram the shooting crime scene and take any measurements of the physical evidence recovered (shell casings) as it was not required by AACPD general orders nor their standard operating procedures. The officer's actions in the "Use of Force" investigation was ruled "Justified" by the Anne Arundel County Police Department.

The crime scene reconstruction consisted of the crime scene being diagramed, measurments taken of the shell casing placements by using the photographs taken at the scene by AACPD, the test firing of AACPD's service issue firearm to determine a shell casing ejection pattern of their firearms, inspection of Mr. Johnson's vehicle, trajectory investigaion of Mr. Johnson's vehicle (front hood and windshield) from bullets striking the vehicle and trajectory evidence of the bullet that struck Mr. Johnson after the bullet had struck the vehicle's steering wheel.

The reconstruction of the crime scene revealed that the officer was not in a stationary position when he fired his service weapon; diagraming the shell casing placements and the test fire of AACPD's service issue firearm for determing shell casing ejections revealed that the officer was walking towards the moving vehicle, into the street, and away from his patrol unit; the trajectory evidence in the moving vehicle's hood and windshield revealed that Mr. Johnson was driving his vehicle in the direction of the officer, but away from the officer and not towards the officer's patrol vehicle; the steering wheel trajectory evidence revealed that the moving vehicle had to be turned to the right to sustain that damage and strike Mr. Johnson, meaning the moving vehicle's steering wheel was turned away from the officer and was headed away from the direction of the officer when this damage was sustained.

A jury found Mr. Calvin Johnson not guilty of ${\bf 1}^{\rm st}$ Degree Assault charges on a police officer.

Civil Investigation

The Law Office of Joseph, Greenwald and Laake, Attorney Timothy Maloney retained my services to investigate a civil complaint to be filed on behalf of Cheye Calvo, Mayor of Berwyn Heights, Maryland, against the Prince George's County of Maryland Sheriff's Department, reconstruct the crime scene that involved sheriff deputies' discharging their service issued firearms killing the Mayor's two (2) labradors dogs, securing the two (2) labradors for their respective necropsy, consult on Prince George's County Sheriff Department's (PGCSD) general orders and standard operating procedures, consult on PGCSD's SWAT Tactics, consult on PGCSD's "Use of Force" investigation involving the sheriff deputies discharging their serivce issue firearm, and reviewing, investigating and critiquing PGCSD detective's investigation.

"On 7-29-2008, the PGCSD's SWAT team responded to the home of Mayor Cheye Calvo of Berwyn Heights, Maryland conducting a drug interdiction investigation and serving a search warrant on his home, not realizing the home was that of the Mayor of Berwyn Heights. The Sheriff's Swat team forcibly enetered the home without knocking and announcing themselves and immediately fataly shot the two (2) labradors and just missed striking the Mayor's mother-in-law who was in the line of fire. PGCSD, after the forced entry and shooting of the dogs, realized that Mayor Calvo had nothing to do with the drug intradiction investigation and was not charged."

The PGCSD conducted a "Use of Force" investigation into the discharging of the deputie's service issued firearm and the killing of the labradors, as the two (2) labradors reportedly charged at the deputies in a threatening manner. A PGCSD Crime Scene Search Unit processed and photographed the shooting scene and collected evidence. The deputie's actions in the "Use of Force" investigation was ruled "Justified" by the PGCSD.

After the crime scene was released by PGCSD, a reconstruction of the crime scene consisted of recovering two (2) additional semi-automatic shell casings and one (1) bullet round fragment that PGCSD failed to recover. A necropsy of the two (2) labradors was conducted and bullets recovered from each of the labrador to determine trajectory evidence of the fired ammunition and the respective placement of the labradors as they were shot. The crime scene was diagramed, measurments taken of the shell casings and bullet fragment placements recovered. These recovered items of eveidence were turned over to PGCSD for further consideration in their investigation into the "Use of Force".

The reconstruction of the crime scene and collection of additional evidence revealed that two (2) deputies, not one (1) deputy, fired their service issued firearm. The necropsy bullet evidence recovered from the labradors and the trajectory evidence revealed that one labrador was shot as he layed at the foot of the kitchen entrance and the second labrador was shot as he was running away from the deputies after the forcibile entry. Neither labrador dog was charging the deputies as reported in the "Use of Force" investigation. The mother-in-law was between the labradors as they were being shot and she received no gunshot injury from this shooting. The reconsruction of the crime scene and collection of additional evidence corobborated the testimony of Mayor Cheye Calvo and his mother-in-law, which completely contradicted the testimony of the PGCSD deputies.

The lawsuit was settled for an undisclosed amount of money with new regulations and policies to be implemented by the PGCSD into the investigation of application and execution of search warrants and "Use of Force" standards.
